PUBLIC PRESENTATIONS/COMMENTS

Solar Energy

Dr. Justin Reaves inquired about the status of his request at the August 2015 Town Board meeting that the Town consider amending its Zoning Law to allow for larger solar kilowatt systems. Since that meeting, he had obtained the signatures of about one hundred (100) persons who supported larger solar projects and asked that New Hartford's Zoning Law be amended accordingly. The Town Supervisor apologized for not getting back to Dr. Reaves but there was no interest or motions made for an amendment. The Town Attorney pointed out that this was a long process, revising the Town's Zoning Law; in fact, the Town Board had appointed a 5- or 6-member citizens committee who put in an awful lot of time, held open meetings with regard to this proposal that was finally adopted and they made changes along the way. It wasn't something that was just a matter-of-fact done; the Town hired an expensive consultant who had worked with a number of municipalities, who worked with the Town. The citizens committee worked with the Town, we held public hearings and everything was explained. It would have been nicer had this matter been brought to the Town Board at that time. The Town Board briefly discussed Dr. Reaves' request for a 44-kilowatt system and whether roof-top units could be used instead.

Erwin Diemiel – resident of New Hartford for 63 years. A neighboring property owner has rented a second story apartment to a musician who has been practicing his drums around 2:00 A.M. daily; recently the drumming starts about 12:00 noon to about 10:00 P.M. and is disturbing the Diemiel's quality of life within their own home. This problem started around July 2015. They have written to the property owner by certified mail, return receipt...but no response. The Diemiel's have contacted the Police Department several times and when a Police Officer responds on site, the drummer stops. They feel intruded upon within their own home. The neighboring property is overgrown with weeds and a trailer with weeds growing from it is parked on the property. Mr. Diemiel mows the area to improve the look of his own property. Police Chief Inserra asked the Diemiel's to reach out to other neighboring property owners who also might be affected by the drumming and to contact the Town Attorney. The question was raised whether the condition(s) would constitute nuisance abatement and/or violations of property maintenance legislation. The Town Supervisor assured the Diemiels that either he, the Town Attorney or Police Chief will be in contact with them.

Web Design for Town's website

Councilman Miscione discussed his recommendation to contract with Delware Net. Inc. for web design of the Town's website. Of the quotations received, he believed that Delware Net, Inc. offered the best services. The total set up cost for 2016 would be Eight Thousand Eight Hundred Twenty Dollars (\$8,820); if paid in full before December 31, 2015, the Town would receive a Twenty Percent (20%) discount. Then in 2017 going forward the annual maintenance fee would be Fifteen Hundred Dollars (\$1500) if prepaid for the whole year that includes all the maintenance, all the support, them helping the Town every time there's an update...they would do all that for the Town. Delware Net, Inc. would host the Town's website on their own server on the cloud so the Town won't have to pay anything extra for technical support or anything like that. The reason Delware Net is giving the Town this deal is because Councilman Miscione assured them that he would work with Delware and the Town department heads to get the content for them. Councilman Reynolds asked what the department heads' stake would be in this; in other words, they would have to be able to supply information? Councilman Miscione responded that it would be everything that was on the survey they had; it's going to be budgets, bidding process, building permits, dog licenses, minutes, etc. Supervisor Tyksinski asked if this was going to take up a lot of time for the Town's department heads, to which Councilman Miscione responded "it's actually not, it's going to actually give them more time." "To accumulate this data?" asked the Town Supervisor. Councilman Miscione stated "the data is going to be accumulated in the beginning so there's going to be some first time...it's going to take three (3) months to put the site together. The data is actually going to be accumulated by me getting the data from the department heads and then giving it to Delware Net." The Town Supervisor noted that his office has copies of all forms used by Town departments, which Councilman Miscione stated would then be available in PDF format for on-line processing. Councilman Reynolds inquired whether a Town department could de-select a transaction type if something isn't working right; Councilman Miscione responded that he would be meeting with "..department heads to see what would make their lives easier" and that the web site will be critiqued for the Town of New Hartford. There are features that can be added, but don't have to. Councilman Woodland inquired about the Police Department's social media and Councilman Miscione confirmed that this would be included. Delware will come down and meet with the department heads. In the future, for example, if the Town chose to add e-mail (through Google), the monthly maintenance/support would increase. What would happen if the Town decided to opt out of the web site in the future, asked Councilman Messa. Councilman Miscione stated the Town would own the content but there would be no support. Directing his inquiry to Deputy Supervisor Matthew Bohn, Councilman Reynolds asked if he had reviewed this quotation and the Deputy Supervisor said no, not this one.

Monthly Financial Report

Copies of the November 2015 monthly financial report had been furnished to Board members and the Finance Director asked if anyone had any questions on the report. In response to one question comparing sales tax revenue, the Finance Director stated that the November 2015 revenue is down \$75,000 compared to November 2014. He said he hopes to end the year in the black. Bills for the year 2015 are still being received for payment so final totals won't be known until around February 2016.

Workers' Compensation Insurance

The Town Supervisor stated that in late summer 2015, upon his request, a motion was made to leave the Oneida County Workers' Compensation program for coverage through a private company. The Town did that and the Town's insurance company obtained quotes, he said. However, in a recent meeting the Town Attorney and Supervisor had with the Town's insurance agent and discussions with County officials, "..this is a little more complicated than previously thought. Essentially, we thought at the time that when we left the County we'd take our existing claims and the new company would take them." At the last meeting we found that's not the way it works. We would either leave the existing claims with the County and they'd get an actuary to determine the value and we'd have to pay a lump sum to the County to assume that. The Town Supervisor's biggest problem with the County plan was the way they allocated administrative costs (1. administrative office costs; 2. claim costs). Currently, costs are being allocated based on assessment which is the Town Supervisor's main reason for wanting to leave the County plan because he believed it was unfair. The Town Supervisor recently has been told that

the County recognizes that it's not a fair practice and, even though they can't change it for 2016, they plan to do so for 2017. That being the case, takes away the Town Supervisor's objections. Some of the private quotes were a little lower than the Town pays now and a majority were a little higher. With everything being taken into consideration, with the threat of going to court, and being told the County premium for 2016 might be less than 2015, the Town Supervisor recommended going back to the Oneida County Workers' Compensation Plan. Starting in 2017 it would be based upon "claims made", not assessment.

Thereafter, Councilman Messa introduced the following Resolution for adoption, which was seconded by Councilman Miscione:

WHEREAS, the Town of New Hartford has obtained information regarding obtaining worker's compensation coverage for its' employees for the year 2016;

NOW, THEREFORE, BE IT RESOLVED THAT, the Town of New Hartford is hereby authorized to obtain worker's compensation insurance coverage through the Oneida County Self Insurance Plan and that the Town Supervisor is authorized to execute any documents necessary to effect said coverage.

Paving – Oneida Street intersection at McDonald's, Washington Mills

Councilman Messa recognized the exceptional job performed by Highway Superintendent Richard Sherman and his crew on the extensive road repairs to the McDonald's intersection at Oneida Street, Washington Mills, with Chapman-Kellogg Roads, a very busy intersection.

Nuisance Abatement – Word of Life Church

With regard to incidents that occurred in October 2015 at the Word of Life Church in Chadwicks, the Town Supervisor stated that a police investigation had been conducted and after completion of the investigation, he had met with Police Chief Michael Inserra and Town Attorney Herbert Cully with regards whether the incidents would play into the Town's nuisance abatement law. After a thorough discussion among the three, it was determined in reviewing the incidents, that the activity met the full criteria against the church under the Town's nuisance abatement law. The Town has been monitoring the situation and checked the church's status as an exempt non-profit organization from documents in the Town Assessor's Office. The church was contacted and asked to submit the proper documents; if documents are filed, the Assessor has been directed to contact the Town Supervisor and Town Attorney. No records could be located by the I.R.S. confirming 501 C 3 status, which raises the question of whether the church is eligible for the exemption they had applied for and have had on the property.

Councilman Messa then introduced the following Resolution for adoption; seconded by Councilman Miscione:

(RESOLUTION NO. 206 of 2015)

RESOLVED that the Town Board of the Town of New Hartford does hereby hire Herbert J. Cully to proceed with Nuisance Abatement law proceedings against the Word

of Life Christian Church, 3354 Oneida Street, Chadwicks, NY 13319, Tax Map No. 349.020-1-22, and to serve the Notice of nuisance on the legal representative of said Church in accordance with the Town Code, Chapter 86, Nuisances, Section 86-4.

In response to Councilman Reynolds' inquiry, the Town Attorney recited the specific nuisances that would be apply in this case:

Section 86-2. Definitions

- G. Any building, structure or real property wherein there exists or has occurred a criminal nuisance as defined by the New York State Penal Law.
- J. Any building, structure or real property wherein an occupant, guest or business invitee commits criminal activities involving assault, gang assault, harassment or disorderly conduct....

[Cully]: "...now, you're aware that a young man was killed as a result of this and another was very seriously injured. A Grand Jury has issued a multiple count indictment against numerous individuals who apparently were members and/or officers of this entity. So I think clearly there was an assault or gang assault, at a minimum."

Section 86-3. Nuisances forbidden

No owner, operator, manager, tenant, lessee or other occupier of a building, structure or real property shall knowingly conduct, maintain, permit or allow the existence of a public nuisance at the building, structure or real property.

[Cully]: "...so the fact that there were apparently members of this Church and/or officers that obviously had notice, because at least from everything I've seen and I'm going by what I've seen in the media, some of them were actually there when this occurred."

Whereupon the Town Board voted by roll call, as follows:

Councilman Miscione - Aye Councilman Reynolds - Aye Councilman Woodland - Aye Councilman Messa - Aye Supervisor Tyksinski - Aye.

The Resolution was declared unanimously carried and duly **ADOPTED**.
