Local Law Introductory "I" of 2018  
Wilbur Road – Ontario Avenue

The Town Supervisor then opened the Public Hearing at 6:01 P.M., in the matter of Local Law Introductory "I" of 2018.[The Town Clerk had available copies of the proposed local law, the Notice of Public Hearing, Affidavit of Posting, Proof of Publication in The Observer Dispatch.

Police Chief Michael Inserra spoke to the need of a 4- way stop at the intersection of Wilbur Road and Ontario Avenue, citing that the traffic issues cause NYMO NYSE and the Town's own Department of Public Works vehicles difficulties in traveling through the intersection. Highway Superintendent Rick Sherman spoke with "the" property owner; the Town removed three trees that were on the Town's right-of-way.

There being no one further to speak in the matter, the Public Hearing was declared closed at 6:03 P.M.

**BE IT ENACTED** by the Town Board of the Town of New Hartford as follows:

SECTION 1. Chapter 113 of the Code of the Town of New Hartford, Section 113-41, is hereby amended to include the following:

Section 113-41. Schedule VII: Stop Intersections

Local Law Introductory "J" of 2018  
Fingerprinting- Fee Increase

The Town Supervisor then opened the Public Hearing at 6:04 P.M., in the matter of Local Law Introductory "J" of 2018. The Town Clerk had available copies of the proposed local law, the Notice of Public Hearing, Affidavit of Posting, and Proof of Publication in The Observer Dispatch.

Police Chief Michael Inserra stated that when the Police Department started offering Fingerprinting to the public over 20 years ago, the fees were set at \$8.00 per resident and \$12.00 per non-resident. The Town is currently charging well under the local agencies, that have a fee of on average of \$75.00,

There being no one further to speak in the matter, the Public Hearing was declared closed at 6:05 P.M.

A Local Law to amend the Code of the Town of New Hartford, Chapter 25 thereof entitled **POLICE DEPARTMENT**, by increasing the charges for fingerprinting services.

**BE IT ENACTED**, by the Town Board of the Town of New Hartford as follows:

**SECTION 1.** Section 25.9 Charges. Is hereby amended as follows:

The cost for fingerprinting for each Town of New Hartford resident applicant is Twenty-five Dollars (\$25).

The cost for fingerprinting for each out-of-town resident applicant is Fifty Dollars (\$50).

**SECTION 2.**

The Town Board may, by Resolution in any year, authorize a change to these fingerprinting fees.

**SECTION 3.**

All other provisions of Chapter 25 of the Code of the Town of New Hartford and amendments thereto, are hereby affirmed except to the extent that this Local Law shall modify or amend.

This Local Law shall become effective immediately upon its filing in the Office of the Secretary of State

**Discussion on 2019 Tentative Budget**

Police Chief discussed the increase in volume of the New York Mills calls due to the village of New York Mills no longer having “24/7” manpower, which therefore leads to the New Hartford Town Police Department to assist and answer calls within the Town’s part of New York Mills. The Police Chief questioned whether the residents of New York Mills be taxed to compensate the large influx of calls attended by the New Hartford Police Department. The Town Attorney, along with the Police Chief, Supervisor Miscione, Finance Director Dreimiller, Personnel Director Schwentzfeier, and Cathy Lawrence; had a lengthy discussion on if the Village of New York Mills had ever been taxed for Police Services before, how a tax rate could be calculated etc.

Councilman Cittadino:

- Had question involving where the monies were coming from for the Highway Part Town – The Finance Director answered that it was mostly coming through Sales Tax.

Councilman Messa:

- Has nothing to add.

Councilman Woodland:

- Animal Control Officer need 34,000 to replace old failing vehicle
- Police Department is asking for \$20,000 added into the equipment budget as the Police Department is now mandated to videotape any felony police interrogation or interview, they only have two rooms currently that they can conduct these interviews in. New system would include 9 cameras, that would be backed up on a hard-drive.
- \$15,000 added to the Police Overtime budget, the way the budget is currently set up they are “set to fail”.

Councilman Reynolds

- Healthcare increases are “out of sight”, ... “a lot of money”.
- Add in a stove and refrigerator for the Senior Center about \$12,000.

Supervisor Miscione:

- Drainage account- move to Highway Part Town instead of Whole Town.
- For clarification, highway whole town revenues, fund balance, last year the Board put in \$65,000 for a bridge (in New York Mills) that was not spent; contractual encumbrance.
- DB51404 put in budget at \$35,000 for brush and leaves for Highway, so they can have a few extra weeks available in October. He did not add in anything for trees or for the memorial park (algaecide clean up).

Councilman Messa:

- On page 2 of 8, questions under personnel, had been given raises (In 2018) for internet and work within the Supervisors office.
- Buildings Personal Services (pg 3 of 8) budget went up from 24,500 to 40,500, was a parks employee that is now part of the Highway Department, he is being used for Buildings and Grounds to take care of the new Town Hall etc. no increase in salary, the difference came out of the Parks budget.
- Raise for Highway – Sewer improvements and upgrades

Councilman Reynolds:

- Fire Districts 1 and 2, talked to the Finance Director, the current rate is 0.7769 and is asking 0.8033 which is a 2% rate increase.

**FURTHER RESOLVED**, that the said Town Board does hereby authorize and direct the Town Clerk to publish the legal requisite Notices of Public Hearing in The Observer Dispatch; and, in accordance with Town Law, Section 106.(4) [Preparation filing and review of tentative and preliminary budgets], sub-paragraph 4, the Town Board does hereby direct the Town Clerk to make twenty-five (25) copies of the 2019 Preliminary Budget for public distribution and to post said document on the Town's website.
