Because the existing speaker system at the Recreation Center broke, the Town Board received three Quotes for the new sound system that's to be installed in the center of the rink at the Recreation Center which is a budgeted item.

Councilman Lenart introduced the following Resolution for adoption, seconded by Councilman Reynolds:

DISCUSSION:

Councilman Messa shared hesitation on spending extra monies at this time especially with the recreation center having a leaky roof and he wanted to know what was left to fix. Supervisor Miscione stated the Recreation Center is a Town asset that the Board needs to put monies into and he said the roof has been leaking for years. He said they are cleaning up the outside of the building and fixing the windows and doors, they bought the chiller because they were spending a lot of money fixing the old one. Councilman Messa asked Supervisor Miscione for a project list to show expenses and Supervisor Miscione stated it's all in the budget. He also explained to the Board that they will see invoices for metal, paint, doors, locker rooms; side walls etc. but that the Town trying to bring the Recreation Center up to standards. He told the Board to come down and take a look at it and he will go over everything with them. Councilman Reynolds verified the paving project will be done this summer and other door renovations. Councilman Reynolds said there all good projects because the building does get used and it needs to be done. Supervisor Miscione said the Town is saving a lot of money because the Town is running the projects themselves, where if they had to go out to bid it would cost a lot more money and these projects are really dressing up the Recreation Center and this is an asset to the Town. Supervisor Miscione told the Board the only project above and beyond the budget would be the roof which he's looking into the last contractor who repaired it and the warranty. Town Attorney Cully stated he had to resend the letter because the address on the contract was the wrong address so he had to research how

to contact the company and resend the letter. Supervisor Miscione stated he has a solution for the roof if the warranty doesn't work with metal and Styrofoam.

TOWN HALL REOPENING:

Councilman Messa asked about the building reopening and Supervisor Miscione stated he's waiting for the County to give approval and they haven't done that yet but although it's not open to the public that staff is still working.

BUDGET ADJUSTMENT-INSURANCE DEDUCTIBLES:

Supervisor Miscione presented Town Attorney Cully with the deductible invoices and Attorney Cully requested to see the insurance policy it's out of before any action is made on budget adjustments.

APPOINTMENT – ZONING BOARD MEMBER:

Councilman Messa stated they had two responses to the Zoning Board Appointment to fill Terry Tesak's term who served over 10 years.

Councilman Messa introduced the following Resolution for adoption, seconded by Councilman Lenart:

This Resolution was declared unanimously carried and duly **ADOPTED**.

STORMWATER STUDY UPDATE:

Councilman Messa inquired if the Study being done has been finalized to date and Supervisor Miscione reported it has not been finalized as they are still doing ground work and finding issues and retention ponds but he hopes it will be finalized with a report and present a demonstration by the end of July 2020.

ONEIDA STREET PROPERTY-Christine Martin:

Councilman Messa stated that NRCS (National Resources Conservation Service) came through and approved the project at the Oneida Street property owned by Christine Martin and agrees to cover the cost up to 75% if the Town sponsors the project and covers 25%. This project was previously declared an emergency at the November 20, 2019 meeting. He reported Mrs. Martin got the approval from DEC (Department of Environmental Conservation) declaring an emergency so the project can begin if the Town sponsors it. Councilman Messa agrees with NRCS (National Resources Conservation Service) with regards to the building and the creek and requests a motion to move this project forward with Town sponsorship.

Councilman Messa introduced the following Resolution for adoption, seconded by Councilman Lenart:

(RESOLUTION NO. OF 2020)

RESOLVED that the New Hartford Town Board does hereby agree to sponsor Mrs. Martin with the Oneida Street creek wall project bearing 25% of the cost and allows the project to begin.

DISCUSSION: Councilman Reynolds agreed and acknowledges the emergency repairs needs to happen however, he thinks it was questioned if Mrs. Martin applied for the grant at this time and he stated she has not been back for any discussion since that last point. Councilman Messa stated the entire project will cost \$125,000.00 and the Towns portion would be \$31,250 (25% of that amount). Councilman Messa reported that the current wall is already 30 feet in from the property. Councilman Woodland asked the Board if any other properties had any similar issues. Highway Superintendent Sherman stated

there are a lot of issues in that area with the Sauquoit Creek. Councilman Lenart reported his understanding was if she applied for the grant and got it then the Town is responsible for the 25% sponsorship. Supervisor Miscione stated they only committed to the sponsorship of the project but not paying the 25% portion. Councilman Messa stated he's worried the building or a portion of it will ultimately end up in the creek, so he feels the Town can't wait on this issue and time is a factor. He also feels if the Town can get 75% of the project covered then that's a good thing. Highway Superintendent Sherman reminded the Board if they agree to the repairs then the Town is responsible for the maintenance of the wall for the next 15 years and the portion of the wall the Town is currently responsible for is almost up. Councilman Reynolds asked Highway Superintendent Sherman what happens after the 15 year commitment is up, what happens to the maintenance of the wall? Highway Superintendent Sherman stated the Town is free and clear of any obligations after the 15 years is up. Councilman Woodland asked what legal issues they would be opening the Town up to if agreed upon. Town Attorney Cully reported the Board is creating legal issues by performing improvements to that piece of private property and he's aware of other issues further downstream so the question becomes why improve this one property and not another one and he continues on stating if the improvements do not work for whatever reason the Town will bear some liability and responsibility. Councilman Messa feels the Town is already having liability and responsibility because NRCS (National Resources Conservation Service) did not carry the wall down far enough. Town Attorney Cully agreed with Councilman Messa that the first project may have contributed to this situation. Councilman Messa said that night the water raised 7 inches but in a normal situation this would not happen and they have 20 to 25 feet of the property gone, that they can't use and without this it's a parcel on the tax rolls. Councilman Woodland questioned if any monies were budgeted for this type of repair? Supervisor Miscione stated no, no monies were budget for this repair. Highway Superintendent Sherman reported there are no monies in his budget for this project as the Town already took it. Councilman Messa questioned the \$12,000 that was allocated for fields in the parks and on the Supervisors' report for the part-time Secretary could decrease from \$30,000 down to \$15,000. Supervisor Miscione stated we don't know where the Town is at yet financially and he doesn't want to allocate money as it may be needed elsewhere which is unknown until the Town opens back up and they see the sales tax revenue report. He said he is already using those numbers to offset the Town's expected deficit. Councilman Messa stated he already came up with \$12,000 and said someone has to have extra monies in there budget somewhere. Councilman Reynolds asked Town Attorney Cully that because this is private property would an easement be involved and Town Attorney Cully replied yes. Councilman Messa stated the property owner would have no issues signing an easement. Councilman Reynolds then stated with all the work that's been done upstream that none of it will impact any buildings downstream (maybe lawns but no buildings) so the impact potential is much less. Highway Superintendent Sherman stated the only reason they did the repairs from Elm Street to where it is today on the rock wall was because a National Grid gas line was exposed and the repair was immediately needed. Councilman Reynolds questioned where the wall was terminated if it made things worse? Highway Superintendent Sherman replied that yes maybe in a large stream of it but if you look at it you will see where the water flows to the right in the opposite direction. Supervisor Miscione commented that Mrs. Martin commented on

facebook live feed "that the sponsoring of the grant has already been approved". Councilman Messa pointed out it was done back at the November 20th 2019 Town Board meeting. Highway Superintendent Sherman pointed out it's not in the minutes. Councilman Messa replied it's in the video discussion ensued at the end of the meeting where it was brought up that Mohawk Limited was discussed and it was declared an emergency and the wall would be fixed through a grant. After a brief pause Councilman Lenart asked if pending litigation was filed and if this should be discussed in executive session. Town Attorney Cully explained that a Notice of Claim has been filed against the Town and the Town is subject to litigation either way. Councilman Messa stated the Town will spend more in litigation fees than repairing the wall. Supervisor Miscione stated his concern was after speaking to the guy at NRCS (National Resources Conservation Service) who's awarding the grant at 75% which is great, he stated this project only affects one person and wanted to know if the Town's in favor of a sponsorship that only affects one private citizen. Supervisor Miscione questioned why is the property owner, being its there property is not coming up with the 25% and why is it on the Town? Councilman Messa questioned why the people with the properties up above didn't kick in. Supervisor Miscione asked if the other parcels affected only one person or multiple people and Councilman Messa replied that doesn't matter. Highway Superintendent Sherman said those properties effected multiple properties along with an exposed gas line. Supervisor Miscione clarified his call with the guy from NCRS (National Resources Conservation Service) who was not sure if the Town was interested in this project as it only involves one person and Supervisor Miscione has not spoken to that guy since then. Highway Superintendent Sherman reported he went out yesterday to look at it and the NRCS (National Resources Conservation Service) guy said he would come back with an estimate as the price is not set in stone. Councilman Messa said the estimate is pretty close and he knows in the past the Town has tried to extend the wall and Highway Superintendent Sherman stated the wall was already extended. Supervisor Miscione asked if the Town was violating the law doing one project that only helps one person and what about the guy whose bridge collapsed and the Town told him they couldn't help him. Supervisor Miscione also said it's the State who said they couldn't help on private property. Town Attorney Cully stated "it's using a municipal fund that only helps one person or residence". Supervisor Miscione stated that's his concern and said again if the property owner were to come up with the 25% then he has no issues with the sponsorship, his issues is coming up with tax payer monies in the whole Town to contribute to that one property. Councilman Messa stated the Town has a piece of property the size of several cars that would bring in multiple dollars in property taxes and he questions why the Board would not do that and he also pointed out he already made a motion that was already seconded. Councilman Reynolds questioned why the wall stopped where it did as they were already on the property at the time of the initial repair. Highway Superintend Sherman replied they got permission for so many feet and he fought the point at the time to extend the wall which they did but NRCS (National Resources Conservation Service) said no to go any further. He further stated they (National Resources Conservation Service) hired an engineer to design it, they (National Resources Conservation Service) hired the contractor and they (National Resources Conservation Service) did the work. Town Attorney Cully stated he feels the liability is on NCRS (National Resources Conservation Service) if the project failed. Supervisor Miscione read a facebook live feed from Christine Martin that read "my tax dollars on this property will likely exceed the

seven properties upstream when I have completed construction". " Councilman Reynolds questioned what Town Attorney Cully said in regards to NCRS (National Resources Conservation Service) and their liability? Town Attorney Cully replied that NCRS (National Resources Conservation Service) raised the issued by improving the first phase, the Town caused and created the problem and he continued to say if in fact the Town contributed to the fact of what caused the problem and if the Town is benefiting downstream properties the Town can do that work, but the issue Supervisor Miscione is raising is the Town is specifically doing something to help one person and one property. Councilman Reynolds questioned if Town Attorney Cully stated NCRS (National Resources Conservation Service) originally engineered the project and Town Attorney Cully stated not the "Town" but by NCRS (National Resources Conservation Service) who completed the work. The Town replied and NCRS (National Resources Conservation Service) agreed to pay 75% of the cost. Councilman Reynolds stated that based on the fact their work failed or even if this is opening a brand new case (Attorney Cully clarified that based on the fact that now there's a need to extend the wall that they did not extend in the first place). Councilman Reynolds continued to ask if they now have some liability to extend the wall further and Town Attorney Cully Agreed that they defiantly do. Councilman Reynolds continued with his point that because Highway Superintendent Sherman specifically asked for the wall to be extended and NCRS (National Resources Conservation Service) did not do that then. He continued to ask if any blueprints or engineering drawings existed. Highway Superintendent Sherman replied yes but they do not show the wall being extended further than what it is today. Town Attorney Cully asked who the engineer was and verified it was not a Town engineer (which was verified it was not a Town engineer with Highway Superintendent Sherman). Councilman Messa commented that based upon the amount of rain that night no engineer can fathom that would ever happen to that magnitude. Supervisor Miscione read a facebook live feed from Christine Martin that said "by the time you look to find blame, the Town of New Hartford will have a school in the creek." Councilman Messa stated their point is the Town does not have the time. Councilman Reynolds said the litigating factor is the wall is already on their property and what failed is contributory to where the wall terminates and that's where the matters got worse. Highway Superintendent Sherman was asked if the Town participated in the approval to extend the wall. Highway Superintendent Sherman verified the Town paid the 25% to put the wall where it is now. Supervisor Sherman has paperwork to tell the Board how much money the Town paid and what they did but they only did the work because of the National Grid gas line being exposed along Elm Street and the second addition was done at the same time. Town Attorney Cully stated that several properties were affected by the exposed gas lines which is why the Town intervemed with the 25% funding where they ran it to the point it hits their property (or extends into their property by 20 feet) and NCRS (National Resources Conservation Service) created the liability on the Town but he's not comfortable going into a lot of detail because there is a Notice of Claim filed against the Town, he's happy to respond further in executive sessions. Supervisor Miscione read another comment form Ellen Hanna who wrote on the facebook live feed "The lack of enforcement in stormwater management above my property has affected only my property because water runs downhill! All those properties above me are contributing to the damage. The water is shooting down behind the restaurant forcing extensive pavement damage and roadway damage which is the Town of New Hartford's responsibility! I should not be the only one

bearing the cost. Please address.” Town Attorney Cully verified the location of her property on Oneida Street. Highway Superintendent Sherman said that portion of Oneida Street is also being included in the study. Supervisor Miscione asked if the Board should take a vote before executive Session and Town Attorney Cully said No, he would go into executive Session now with no vote.

Upon recommendation of Town Attorney Cully the Board passed the following resolution:

RESOLVED that the New Hartford Town Board does hereby agree to sponsor the NRCS (National Resources Conservation Service) project on Oneida Street owned by Christine Martin.

NCRS Project on Oneida Street – 25% Fee:

Councilman Messa introduced the following Resolution for adoption, seconded by Councilman Lenart:

(RESOLUTION NO. OF 2020)

RESOLVED that the New Hartford Town Board does hereby agree to pay the 25% fee that is not covered by the grant (approximately \$31,250) with the NCRS (National Resources Conservation Service) project to build the wall on Oneida Street on the Martin property (Parcel 349.020-1-22).

Discussion:

Councilman Reynolds stated NRCS (National Resources Conservation Service) has some liability in this matter and it's his belief and understanding the Town at the time asked NRCS (National Resources Conservation Service) to extend the wall project which would have covered the questioned area. He thinks that the fact the wall ended where it did exacerbated the problem, so he feels they have some liability here.

This Resolution was declared FAILED....

Councilman Messa questioned if Christine Martin should go to NRCS (National Resources Conservation Service) for the 25% fee and Town Attorney Cully stated the Town should go out for a print because it's his understanding they had a specific request from Highway Superintendent Sherman to extend the wall and NRCS (National Resources Conservation Service) determined they did not have the funding at that time and they did not comply with the Town's request for the wall to be extended. He feels the Town should help this citizen to the greatest extent provided and with information as he understands it, she has everything through FOIL (Freedom of Information Law) but certainly anything the Town can do to assist her in her efforts then it should be done. Supervisor Miscione agreed with Town Attorney Cully that NRCS (National Resources Conservation Service) has liability as their engineering work was wrong so he suggested Christine Martin go after NRCS (National Resources Conservation Service) for the 25%

fee and continued to say if not then she should be responsible for the 25% fee and the Town will just sponsor the project which is a win/win for everyone.

Salary Adjustment - Deputy I Melody K. Fancett:

Councilman Messa brought up Deputy Clerk I Melody K. Fancett's e-mail requesting a stipend of \$10.50 per hour retroactive to March 1, 2020 as she has taken on the duties of Deputy Clerk II which is currently vacant. Councilman Woodland asked what extra duties are involved and Deputy Clerk I Melody K. Fancett responded by saying the Town Board Minutes, Mail, Customers, all the various licensing, (dog, marriage etc.) parking permits. She explained normally there are two of us but now everything is on her and she's keeping up and doing the duties and this is a budgeted position. Supervisor Miscione asked about the Deputy Registrar Kayla Empey and why she can't assist with extra duties. Deputy Clerk I Melody K. Fancett explained she's very busy with death certificates and that she is also assisting the Deputy Registrar Empey with her duties of birth records through the mail and customers. The Town Board urged Kayla Empey to answer more phone calls as they are getting several complaints. Deputy Clerk I Melody K. Fancett told the Town Board that there is a lot of time that she's not taking a lunch hour and working nights and weekends to keep up which is not an issue for her, the issue is she would like to be compensated for the extra duties until the position is filled. Supervisor Miscione stated the lunch hour is mandatory by law and she needs to take the hour and abide by New York State Labor Law. Supervisor Miscione stated he would be more comfortable consolidating the two positions into one which would save the Town money. He also asked if some tasks could go to the Deputy Registrar Kayla Empey and the Town Clerk Gail Wolanin Young responded no because her work is full time work as it is. Supervisor Miscione stated she can certainly take on some extra little duties to help the office out so the Town doesn't have to hire another full time position then give Melody Fancett her stipend to make her a happier employee. Town Clerk Gail Wolanin Young commented the Deputy Registrar is still provisional as she has not taken the Civil Service Test yet. Melody K. Fancett stated she was only asking for the stipend to be temporary until the position is filled but has no complaints with taking on both jobs as long as the Board was aware some overtime will be required as it's a lot of work and can't be done in 8 hours. Supervisor Miscione questioned Town Clerk Gail Wolanin Young to make sure she's ok with this agreement (Melody K. Fancett taking on both the Deputy I and the Deputy II full time job) because she's a department head and the Board can't make that decision for her. This still would leave the part-time position still in the budget. They will discuss the salary in executive session if Gail Wolanin Young, Town Clerk is ok but he's not in favor of anything retroactive. Melody K. Fancett explained her job is at the leisure of the Town Clerk and is not a civil service position. Town Clerk Gail Wolanin Young said she's comfortable with this change. The Board did state they will not fund the position as long as Melody K. Fancett is doing both jobs. Town Attorney asked if the FOIL's were an issue, and Deputy Clerk I stated no, FOIL's were not an issue but clarifying the law may be but that's where the Town Attorney comes in. Supervisor Miscione asked Town Clerk Gail Wolanin Young to ask her Deputy Registrar Kayla Empey to answer phones more and start taking messages more. Deputy Clerk I Melody K. Fancett stated a part-time person at 17 ½ hours which is budgeted would be very beneficial as to just answering phones and taking messages. Supervisor Miscione stated the phones are very important and it would be a better

process. Supervisor Miscione did state he's not in favor of going retroactive. Deputy Clerk I Melody K. Fancett did state the salary would be the key because she's already one of the lowest paid employees with the Town who has already taken on several extra duties with no compensation. The Deputy II position will not be eliminated and will remain vacant and unfunded as long as Deputy Clerk I Melody K. Fancett does the job. Town Clerk Gail Wolanin Young did say the Deputy Registrar Kayla Empey can answer more calls and take messages if she's available. The call volume is constant and extremely high all day. Melody K. Fancett did express that the part-time person would be extremely important to me doing both positions to alleviate the phones, and small duties.

Fancett to \$23.00 per hour effective May 14, 2020 due to the extra duties of Deputy Clerk II, which is vacant and due to the fact the Town Clerk’s Office will not fill the Deputy II position.

Highway Superintendent Sherman explained what his guys were doing and how the COVID 19 is working with them. They are all on split shifts as of Monday; they are all working together, keeping their distance and all wearing masks and PPE equipment.

The BMX society has requested to participate in the Sherrillbrook Park having tournaments with the course to be built through a grant (\$25,000.00). The Town would have to clear some wooded areas where they now have dead trees but it would be available for public use. They are interested in the Town because of the hotels and restaurants as many of the participants of the tournaments and travel with kids. Some of the terrain would be paved and some would be dirt. It’s a fun, big sport and it would be in a controlled environment. The question of liability insurance was mentioned and Supervisor Miscione stated they would have their own insurance and would run their own events. Anyone including Town residents could participate in events, competitions and tournaments. Supervisor Miscione said if the Board is interested he will have them come do a public presentation and Councilman Reynolds is interested in hearing more about the location in the Park. Councilman Lenart questioned if the Town was being asked to sponsor events and Supervisor Miscione stated no, it’s just

an addition to the Parks. Councilman Messa was a bit concerned with the jumps and the liability. Supervisor Miscione stated it will be fenced in and controlled. He said if the Board is interested in natural activities then he will spend more time in getting the presentation together for the Board. Attorney Cully was interested in looking at other municipalities with similar events and how they do it. There was talk if the course could be bigger they could be chosen to host a national race but where they are located now it does not have the ability for that. There looking for a better location. A demonstration will be forthcoming.
